I/we request permission to participate in cross-country horseback riding and fox hunting with Montana Horses Inc.

I/we fully understand that cross country horseback riding and fox hunting **ARE VERY DANGEROUS ACTIVITIES** that include riding unsupervised at all gaits, over fences, other obstacles, and on difficult, steep, uneven and rough, rocky, slick, and icy terrain, in various weather conditions that are often inclement, and in remote locations without emergency services or telephone/communication.

I understand that I am riding at my own risk and acknowledge that my participation in this activity could result in INJURY OR DEATH. I/We acknowledge and understand the risks of injury or death to me/us or my/our property.
